## What Are the Oracle Java Licensing Changes?

Users of Java SE (Standard Edition) have previously been able to download Java for free under a variety of licenses. However, for releases and updates post April 2019, Java is subject to subscription licensing with very few exceptions.

## How Does This Affect Organizations?

Oracle are expected to begin auditing Java estates this year and the associated costs can quickly start to add up for larger organizations. With an Oracle price banding model, the higher the volume, the lower the unit pricing so Oracle can entice customers to bulk-buy Java subscriptions as an alternative to documenting their estate. As a strategy, if you commit to buying licenses to support your Oracle Java estate, then you are tied into a subscription model in order to continue using the Java software that you've built your business upon.

While the costs do not appear to be significant, they can quickly add up. Let us look at Example Inc., with a moderate estate containing 6,000 desktops. The Volume band they would be in is 3,000-9,999, with a monthly cost of \$1.75 per desktop. Based on this information, the total annual cost is calculated as:

If Example Inc. do not take steps to quantify their exposure, they will be unaware of the costs they are liable for. Now, imagine two years later Oracle perform an audit of their IT estate? Example Inc. could now be liable for \$252,000 in back maintenance, just for Java desktop licenses. This does not include servers or other aspects of the Oracle estate.
